

**2026 NAVIGANT CREDIT UNION – EMBARK SCHOOLS OUT FOR SUMMER
CAMPAIGN
OFFICIAL RULES**

NO PURCHASE NECESSARY TO ENTER OR WIN. PURCHASE WILL NOT IMPROVE CHANCES OF WINNING.

ELIGIBILITY: OPEN ONLY TO LEGAL RESIDENTS OF THE 50 UNITED STATES OR DISTRICT OF COLUMBIA WHO ARE AGES 13-22 AS OF DATE OF ENTRY. RESIDENTS WHO ARE AGES 13-17 MUST BE ACCOMPANIED BY A PARENT OR LEGAL GUARDIAN. TO ENTER BY OPENING AN EMBARK CHECKING ACCOUNT: To enter, participants must open an Embark Checking Account in one of the NAVIGANT CREDIT UNION branches, including digital account during the Promotional Period to be automatically entered to win a pair of Beats Headphones and \$30.00 Amazon Gift Card. **The amount of the transaction will not increase or decrease chances of winning.** Primary account holders 13-17 years old require a parent or legal guardian as a joint owner on the account. Parent or legal guardian must agree to all obligations and undertakings of the Sweepstakes, both on behalf of himself/herself and the primary account holder that is 13-17 years old. Embark Checking Account entries must be completed and submitted by 12:00:00 p.m. ET on June 27, 2026, in order to be eligible for the random drawing.

Entry forms must be completed and submitted by 12:00:00 p.m. ET on June 27, 2026, to be eligible for the random drawing.

DRAWING: One (1) winner will be selected in a random drawing from each NAVIGANT CREDIT UNION branch location, including digital branch held at the end of the day on June 27th from among all eligible entries received at each branch location. Drawings will be conducted by the Sponsor, whose decisions are final and binding in

all matters relating to this Sweepstakes. The winners will be notified by phone and/or email to the phone number and/or email address associated with their eligible Embark Checking Account or included with their entry form within five (5) business days following the drawing. If a potential winner is a minor at the time of entry in his/her jurisdiction of residence, prize may be awarded in the name of, or to, winner's parent/legal guardian who must agree to all obligations and undertakings of winner, both on behalf of himself/herself and winner, or prize may be forfeited and awarded to an alternate winner. Sponsor is not responsible for false, incorrect, changed, incomplete or illegible contact information.
